

Project Financing

The GEF Small Grants funding covers the incremental costs related to projects. Incremental costs are additional costs associated with transforming a project with national benefits into one with global environmental benefits. The GEF is a co-financier operating on a 1:1 partnership arrangement in financing of projects. The Programme provides small grants, up to USD 50 000.00, directly to NGOs, CBOs and other recognized community entities for environmental projects. Contribution by grantees may be in cash or in kind and can be raised through partnerships with donors, government, academic institutions, private sector, business sector and other stakeholders.

What is The GEF Small Grants Programme (SGP)?

It is a corporate programme of the Global Environment Facility (GEF), implemented by the United Nations Development Programme on behalf of the GEF Implementing and Executing Agencies. The SGP is country-driven and operates in a decentralized and flexible manner by establishing a Country Programme that is led by a National Steering Committee with the majority of members from the civil society. The Programme provides financial and technical support to projects in developing countries that conserve and restore the natural world while enhancing well-being and livelihoods of people.

Five-year Vision for the Country Programme

"To protect the natural heritage of Lesotho through empowerment of local grass-root level communities to engage in viable partnerships for undertaking environmental management projects that generate sustainable livelihood benefits and preserve the integrity of ecosystems of global significance."

Who can Apply for Funding?

Grants are made directly to Non-Governmental Organizations and Community Based Organizations and other recognized community entities, in recognition of the key role they play as a resource and constituency for environment and development concerns. These entities should be involved directly or indirectly in natural resources management and other activities that generate income, empower communities and contribute towards environmental protection. Guidelines for project development and selection process are obtainable from the GEF SGP Country Office at the address provided.

Eligible Activities

Eligible activities include:

- Community-based assessment and planning,
- Pilot demonstrations,
- Capacity development,
- Applied research & policy analysis,
- Awareness raising and education,
- Dissemination of project results and lessons learned, networking and policy dialogue
